## Consumer Consent

I further consent and authorize NB Power to:

1. Collect my personal information provided to the dealership.
2. Retain my personal information for the purposes as set out below.
3. Use my personal information provided to the participating dealership for the purposes of receiving the Plug-In NB rebate under the Program, as described and for the purposes outlined below; and
4. Disclose my personal information to the Minister of Natural Resources and Energy Development for the purposes outlined below.

This information is being collected by NB Power and will be shared with the Minister of Natural Resources and Energy Development and/or their delegated employees for the purpose of:

1. administering the Program, which includes but is not limited to determining the eligibility for a rebate under the Program and evaluating the Program including informing future program policy related to electric vehicles; and
2. validating eligible electric vehicle purchases, which involves reviewing the vehicle identification number and the personal information of the purchaser / lessee.

The personal information collected will be shared only with those employees of NB Power (as Program Administrator) and the Department of Natural Resources and Energy Development as is reasonably required for the administration and evaluation of the Program. Under the provisions of the *Right to Information and Protection of Privacy Act*, individuals have the right of access to, correction of and protection of their personal information.
